
Dear Panicos and Elli:

It will be great to see you both.

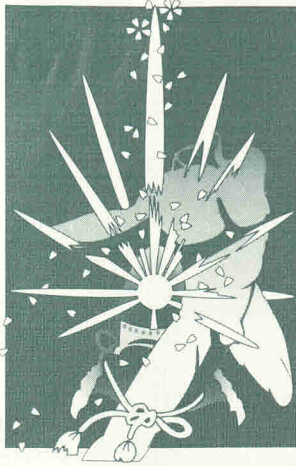
